<u>August 26, 2025 Executive Session Minutes:</u> MSP: To approve the August 26<sup>th</sup> Executive Session Minutes. Councilor Brandt/Councilor Demaris. Mayor Wise, Councilors Marsha Demaris, Darold Smith, Charlie Briscoe and Sherry Brandt voted to approve.

#### REPORTS

<u>SVFD</u>: Kurt Clarke (FD) At the last training meeting they included safety training as well. The SVFD also installed a pole/windsock in the LZ at the Event Grounds for medical aircraft landings. There was one medical call since the last report.

#### **NEW BUSINESS**

a. Gaslin Report: Mr. Gaslin provided and presented the council with August budget and bills to be paid for the month. MSP: To approve and pay the bills as presented.

- b. Amend Fee Resolution 396-21: The council discussed the need to add the flea market vendor fees (standard & food) to the fee schedule. Addition of NSF returned check fee of \$35. As well as adding a new fee of \$25 per event to 501C who schedule rental time at the School House. MSP: To amend Resolution 396-21 to include the flea market, NSF and new School House use fees. Councilor Demaris/Councilor Brandt. Mayor Wise, Councilors Marsha Demaris, Darold Smith, Charlie Briscoe and Sherry Brandt voted to approve.
- c. ATC Tower: Discussion TABLED and will be moved to an Executive Session.
- d. LOC Voting Delegate: The LOC is asking that every city has a representative to vote on delegates to the LOC Board. Resolution 443-25 is to appoint a city delegate. Councilor Sherry Brandt volunteered to be the city delegate. MSP: To approve Sherry Brandt be the delegate for Resolution 443-25. Councilor Demaris/Councilor Smith. Mayor Wise, Councilors Marsha Demaris, Darold Smith, Charlie Briscoe voted to approve. Councilor Sherry Brandt abstained.

#### **OLD BUSINESS**

- e. Cemetery Update: Matt Armstrong spoke to the council updating them on progress and needs for the cemetery. A backhoe will be needed to remove stumps before Matt can move forward with installing the stakes/tags. Jon Patterson offered to help with the backhoe needs. Terry Valentine donated a new sign for the cemetery.
- f. Baker County Parks Board: Councilor Demaris and Matt Armstrong are on the board and Mayor Wise requested an update on the recent board meeting. The board had discussions about putting in trails through the tailings, trout stocking Powder River, and ponds.

# **COUNCILOR COMMENT**

<u>Darold Smith:</u> Would like to have an Executive Session on the Flea Market and Vendor Fees at a future date.

<u>Marsha Demaris</u>: Spoke with some citizens about the upcoming public meeting. Mentioned that the cost of chlorine has gone up and that we are no longer able to return the empty barrels for a credit. The water that the public uses to water their lawns is chlorinated and to please be mindful of usage.
